



## WELLNESS ELECTRONICS INDUSTRY LEAGUE

**A new organization under development by California Citizens For Health Freedom**

September 2003

Dear Wellness Electronics Manufacturer, Distributor or Supporter:

As you may know, the FDA / FTC / "Operation Cure All" alliance is preparing to bring criminal indictments against some manufacturers and distributors of wellness electronic equipment, particularly of Rife machines this fall. These indictments are intended as opening salvo's of a new emerging campaign to destroy an effective industry which they see as bogus.. The FDA and the Federal Trade Commission have long histories of targeting a few individuals or firms to use as examples to intimidate others in their campaign to destroy or cripple a particular industry.

This has led to efforts by some of the manufacturers, private citizens and others to form an organization called the Wellness Electronic Industry League (WEIL). The law firm of Turner & Swankin has been employed to lead the defense efforts, which are estimated to be in excess of \$20,000.00 a month. If the government wins this court battle, a dangerous legal precedent will have been set. Then, you and your firm could be their next targets. If we are successful there will most likely be a moratorium on legal actions. We have an unprecedented opportunity in an upcoming meeting with the FDA / FTC prosecutors in late September or early October to stop their assault on the industry cold. We have strong indicators that the FDA / FTC will back off from the industry and abandon their plans to bring indictments, if our legal team is empowered to show them we are a united community that can beat the FDA in court with the strong evidence we have that wellness electronics works and is helping people.. Your support now will empower our legal team. Your support can help us bring you more freedom for your business to grow and prevent reckless Federal destruction of the industry through suppressive intimidation and relentless court battles.

WEIL will also fight for critical legislative changes. Until a federal law is passed to make the use and sale of Rife, and other electronic wellness machines legal, the FDA / FTC may only temporarily retreat from actively attacking the industry for a few years. Effective federal legislation can drastically reduce the need for a permanent war chest and stop the FDA /FTC from engaging in future mischief for generations to come.

The legal defense, community organization and legislative advocacy necessary for passage of a federal bill can not be done quickly or inexpensively. The first steps have been taken for you and it is now time for you and others with economic interests in this issue, to become actively involved in this effort. The old adage of "united we stand, divided we fall" was never more applicable than to this situation. At this time most of the leadership role in defense of the industry is being provided by individual citizens who are not manufacturers or distributors but who feel strongly about medical freedom.

It is vital for the various facets of the industry to set aside their fears and differences and assist in forming an organization such as WEIL that will represent their industry. WEILS, a companion (spin-off) organizations could also be created when or if that would more appropriately serve the interests of wellness electronics users in support of the industry.:

- 1) W.E.I.L. = Industry: manufacturers and distributors.
- 2) W.E.I.L.S.= Supporters from the Health and Medical Professionals community who
  - a) use Rife and wellness energy technology in their practice; or are
  - b) Individuals, who for personal reasons, want to be involved in helping defend their right for access to the equipment.

The organizing committee for WEIL has requested that California Citizens for Health Freedom, a 501-C-4 non-profit citizens' advocacy organization, be the banker for WEIL/WEILS. CC4HF has had many years of experience in providing leadership and successful political action in support of the Health Medical Freedom Movement, at both the state and national levels. The WEIL monies will be maintained in a separate, dedicated, bank account. Monies donated to the W.E.I.L./W.E.I.L.S. fund via CC4HF will be used to pay the organizational and political advocacy expenses for the emerging organization and support the legal defense. Although donations to this fund are not tax deductible they may be used as a business expense.
